SECTION 2: SUMMARY OF BRIEF

Proposals are requested from service providers that have the services required and capabilities to hire and servicing of mobile toilets to the Amahlathi Local Municipality area of Thomas River in Toise.

SECTION 3: PROJECT DESCRIPTION / BACKGROUND

The Amahlathi Local Municipality mandated with the maintenance and construction of Gravel roads with associated storm water structures that have been demarcated to the local authority. The Municipality will provide non-flushable toilets to the construction of Welisizwe Bridge in the Thomas River. The project will take place in the area of Cathcart within in Amahlathi Local Municipality.

SECTION 4: PROJECT PURPOSE / OBJECTIVES

The purpose of this project is to appoint a service provider that will be responsible for hiring of non-flushable mobile toilets with toilet papers and cleaning service at the Amahlathi Municipal area of Cathcart (Thomas River).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
