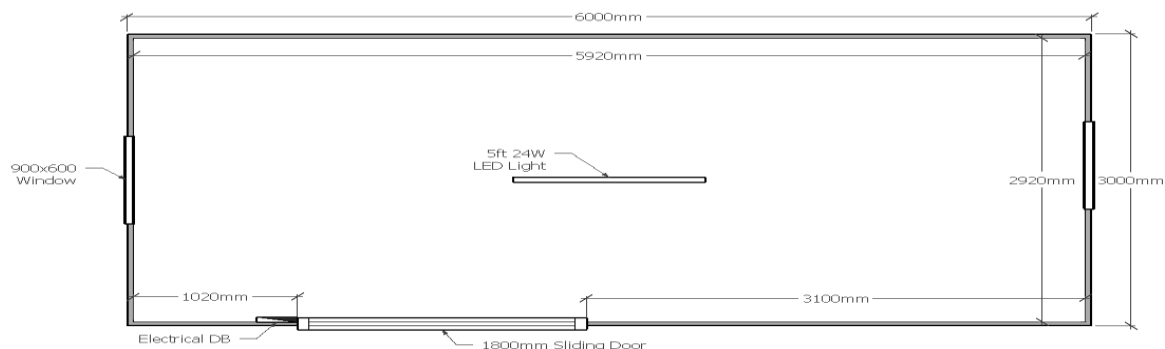
SPECIFICATION SUPPLY, DELIVER AND ASSEMBLE 6X3M Insulated Container

Comprises the **supply, deliver and assemble 6mx3m Insulated container**, workmanship, safety measures, transport, and everything stated or implied which is, or may be necessary.

The Minimum Specification requirements are (but not limited to) the following: -

Site Preparations and Excavation for 6x3m Insulated Container:

- Remove all grass roots, Clear topsoil from a space larger than 6x3 meters
- Excavate 300mm deep ensuring the area is level and flat
- Compact the soil to prevent future shifting and erosion
- Lay 100mm layer of crushed stone or gravel then compact
- Install any required under-slab conduits (water, power or drainage) before pouring concrete
- Place Heavy duty plastic damp-proofing water barrier and steel reinforcing mesh or rebars
- Pour 200mm Concrete mix, screed the top flat, and smooth it with float and ensure ground sloped for water flow
- Embed anchor plates or twist lock container corner twist locks into wet concrete for direct tie-down.
- Allow the slab to cure for at least 7days while keeping it damp before placing the container
- **Stairs 1500mm Tread x 175/200mm Riser:** Calculate the total rise from the ground to your container floor slab, divide by preferred **Riser height 175/200mm per step**, brace boards securely and insert rebars tied to formwork and pour concrete, vibrate screed smooth it with slightly sloped float for water flow **OR** provide heavy duty non-slip durable metal mesh frame staircase with Handrail assembled to the container
- Remove wood forms and clean the site of all materials.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
